# 1. Online Study Policy Scope

### 2. Roles and Responsibilities

Trustees:	Overall responsibility for safeguarding arrangements within the School		
Head and deputy	Overall executive responsibility for the safety and welfare of members of the

Tutors and volunteers	Have a responsibility to act as a good role models and share their knowledge of the School's policies and of safe practice with the students		
Parent/Guardians:	Ensure students understand how to keep safe online, promote safe practice and assist students with their work		
Students:	Utilise the resources provided for a positive learning experience		

# 3. Education and Training

Providing supervision, support and training for all users about online safety. The frequency, level
and focus of training will reflect individual roles and requirements at the School

# 4. Procedure for Dealing with Incidents of Misuse

- Anyone who has a concern about the misuse of technology by any other user should report it immediately to the relevant tutor and the head teacher
- The School reserves the right to suspend access to the School's network by any user at any time and to report suspected illegal activity
- Review the policy at regular intervals, to ensure any problems are resolved in the long term

# 5. Monitoring and Review

- The effectiveness of the School's online study policy and the education of students about keeping safe will be discussed by tutors and trustee meetings
- The School we review and update the security of our information systems regularly

## 6. School Agreement

- Ensure the safety and wellbeing of all users of Al-Mizan online tools and resources
- Usernames, logins, email accounts and passwords are used effectively and should not be shared
- Personal information about users who are involved with the School will be held securely
- Electronic material, including images and videos are used with permission from parent/guardians
- Developing clear and robust procedures to enable us to respond appropriately to any incidents of inappropriate online behaviour by whomsoever
- All material and tools used or created via the resources provided by the School remain the property of the School. Parents/guardians or students can seek access upon leaving and the School will use best endeavours to retrieve all the relevant material.
- Confirm agreement from all users to abide by the requirements detailed herein

### 7. User Agreement

**Note to Parents/Guardians**: Please read and discuss this agreement with your child/children each time you register their account and ensure they understand the issues being addressed. Parents/guardians must confirm their child/children will abide by the behaviours and requirements detailed below. When setting up a user account online agreement will be requested for each user.

This policy and agreement apply equally to all students, parents/guardians, tutors and volunteers involved with Al-Mizan's activities and who individually agree to:

- Only use the online resources provided through Al-Mizan for their intended purpose
- Operate within our Islamic values and the law of the UK in terms of using online tools and resources
- Take responsibility to maintain respectful behaviour and language during lessons and other times
- Maximise opportunities for learning and remain safe from potential harm online
- Not to assist, perpetrate or be party to abuse of any kind, whether online or elsewhere
- Not to record or distribute any video material of the lesson without permission of the head teacher
- Not to deliberately seek to access material that could be considered offensive or illegal. Any accidental access to such material will be reported immediately to the tutor or head teacher.
- Not to use any material that could be considered threatening, bullying, offensive or illegal
- Not to share any personal information, usernames, logins, email accounts and passwords of others
- Not to share one's own usernames, logins, email accounts and passwords to anyone
- Not to arrange a face-to-face meeting with anyone unless discussed with a parent/guardian
- At first privately notify and discuss with parents/guardian or the head teacher or deputy head teachers should anything unsuitable or concerning be found online and linked to the use of the online resources provided by the School
- Al-Mizan monitoring online activity for the purposes of the School function only

By accessing Al-Mizan online content I understand and consent to abide by the above rules, which are designed to keep students, parents/guardians, tutors and volunteers safe. If I disregard the rules Al-Mizan may take appropriate action to suspend access to the resources available through the School.
